2019 WESTGATE LAS VEGAS SUPERCONTEST RULES AND REGULATIONS

The "Westgate Las Vegas 2019 SuperContest" (hereinafter the "SuperContest", "Contest" or "Promotion") refers to the events commencing Friday, March 1, 2019 at 9:00AM. and ending on Sunday, December 29, 2019 (pending no games are in delay per rule 24).
